MESSAGE FROM The President

All members of the Heath Alliance for Care family – Heath Village, Canterbury Village and Heath Care Management – continued to demonstrate financial strength during the fiscal year ending June 2013 while keeping cost increases to a minimum.

At Heath Village, we began the implementation of our longterm strategic master plan by completing the modernization of Heath House and the renovation of the Health Care Center. This September we began the re-configuration of the new Great Room, the addition of a new Game Room and the renovation of the dining facility to include a Pub and Grill, a formal dining area and a demonstration area for the Chef's presentations. These changes were and are implemented while maintaining the Heath Village staff of approximately 200 hard-working and dedicated people to serve the needs of some 400 residents.

Heath Village management headed by Patrick Brady, CEO, has again done a superb job of operating the facilities on a day-to-day basis and

preserving and upgrading the services and amenities which enhance the quality of life for all the residents. Special thanks must be extended to staff and residents of Heath Village, Board Members and the community at large for supporting the Friendship and Gift Annuity Funds which were created years ago to help current residents remain at Heath Village in event their ongoing needs unexpectedly exceed their financial resources.

On the other hand, Canterbury Village completed its expansion from 40 to 53 beds and the upgrade of its existing facility in West Orange and held a ribbon cutting ceremony last April. Over the past two years, Canterbury Village has had to turn away some prospective residents and place them on a waiting list. The expansion and upgrade will enable us to continue to meet the needs of our current and prospective residents.

Heath Care Management, our for-profit management and consulting company continues to expand with management

and therapy contracts. Revenues will approach \$2.5 million in 2013-2014.

As I begin my third year in office, I look forward to continuing the work of my predecessors and seeing further implementation of the Master Plan at Heath Village. I am confident that the current fiscal year will be as successful as the last, with the help and support of my colleagues on the Board, our caring staff, our friends, vendors, community partners and the residents of our communities.

FROM THE DESK OF THE... Chief Executive Officer

Last year, as I was writing the recap of 2012, we had no idea that in a few weeks Heath Village would be confronted with Hurricane Sandy. Sandy was the most damaging storm seen in New Jersey for over a century. Heath Village, through the yeoman efforts of the staff kept all residents safe, warm and secure while providing meals and activities-all of this on emergency generator power. Electricity was lost for three days, but the spirit of teamwork could be found throughout Heath Village and the staff and resident co-operation was phenomenal.

The year 2013 was one of continued progress: renovations and improvements to Heath House and the Health Care Center was the focus. Many apartments saw vast renovations and expansion in size to fit the needs of the next generation of Heath residents.

The Board of Trustees and Administration continued to plan and execute the Heath Village Master Plan which will bring about major improvements in 2014. We look forward to the addition of a new Game Room, Great Room and outdoor social space and a complete renovation of our Dining Rooms. The Dining Room renovation will include a formal dining area with Center Stage area for chef presentations, a Grill Room and a Pub, as Heath Village now has a "Club" License for drinks. All of the above projects have a target completion of mid-2014.

Once again this year, Heath Village has had an array of special events including the Friendship Fund Gala, our annual Horseshow and Family Day. Heath Village staff works extra hard to make these events very special.

Helping our residents financially continues to be a priority. Fundraising efforts this year produced contributions of \$240,250. The Gift Annuity Program made up \$18,000 of that total. Generous residents, staff and board members, family, friends and vendors donated \$29,950 at this year's annual Benefit Gala. During 2012-13, \$471,300 was expended to assist 13 residents. The Friendship Store and Village Shoppe brought in a total of \$21,000 in proceeds. As of this writing, balances of the Friendship and Gift Annuity Funds total \$2.7 million and \$1.5 million, respectively.

I commend the Village's Residents' Council for their





Residents' Council MESSAGE FROM THE PRESIDENT

There are only a few more months before my term on the Residents' Council is complete. I have spent the last two years as President of the Council and I would be remiss if I did not take the opportunity to thank all of the residents, with whom I had the pleasure of working. Without the help and cooperation of all the members, it would have been a much more difficult job. I would also like to thank the Administration for their help and guidance over the past three years. It is this spirit of "family" that makes Heath Village a unique community.

An important part of life here at Heath Village is the Residents' Council. The Council acts as a liaison between the residents, administration, staff members and the many volunteers to continue to improve and maintain our lifestyle.

The Council, which meets every second Monday of the month, except for July and August, consists of nine members elected by our residents for threeyear term. The Executive Committee consists of a President, Vice-President, Secretary and Treasurer. A Council member "chairs" one of the following committees: Newcomers, Dining Services, Maintenance and Operations, Friendly Visitors, At-Large and Special Events. One resident is appointed to serve as the liaison between the Council and the Board of Trustees and attends and reports on their meetings. The Council also invites a member of the Board of Trustees to attend our monthly

meetings, setting up a continuous line of communication between residents and Trustees. Council members also meet and greet visitors on Open House days in the Spring and Fall.

The past year has seen the introduction of a new Medical Alert System. It is triggered by the resident and in emergencies allows for instant communication with medical personnel. This will ensure the immediate response necessary for our well-being. The installation of wi-fi campus-wide is almost complete. This will help to keep the Heath Village campus in the 21st century. This year also saw Heath House undergo renovations and work in the Cloisters area.

There are over forty different clubs and activities available to our residents. They cover the entire range of mental, emotional and physical well-being. Residents are encouraged to participate in any of them. The Friendship Center allows residents to interact in intergenerational relationships and activities with preschoolers.

Once again I thank everyone for their help and wish you all a year filled with health and happiness, and may Heath Village continue to be the beautiful place that it is.

Heath Care Management

Heath Care Management is the for-profit corporation which operates under the Heath Alliance for Care corporation.

Heath Care Management has five divisions:

- Therapy Services
- Landscaping and Grounds
- Housekeeping Services
- Management and Accounting Services
- Salon Services

Revenues in 2012-2013 were slightly over \$2 million. Our Therapy division has a contract with King James Nursing Center in Chatham, NJ. King James is 108 beds of Nursing and Sub-Acute Rehabilitation Services. Heath Care Management supplies the physical, occupational and speech therapy for King James. In 2013, Heath Care Management also took over complete management and administration at King James. Landscaping and Grounds is the second largest division accounting for approximately 25% of Heath Care Management's revenues. This group has several landscaping contracts with area business and residential properties.

Our Housekeeping and Salon divisions provide services on the Heath Village campus. Management and Accounting Services offer consulting expertise to long-term care providers. Management consultation contracts in 2012 included providing Intergenerational Child Care consultation to the Aviv Health System outside of Boston, Massachusetts.

Heath Care Management, Inc. has provided Management and Facility Management for over fifteen years and continues to expand on an annual basis.

Canterbury Village

This past year at Canterbury Village has been one of significant change and growth. Our construction and renovation project, which began last May, was completed this March.

Our ribbon cutting ceremony was held on April 18th with former governor, Richard Codey as guest speaker. Other invited guests included, members of the Canterbury Board of Trustees, West Orange Township council members, our architect, contractor and resident families.

We are so pleased to have a greater variety of gracious living areas and amenities which now include a beauty salon, country kitchen, library and a dedicated arts and crafts area as well as room for 13 additional residents. The two new courtyards are popular spots to host activities, or just to sit out and relax. The overall response by our residents, family members, visitors and staff has been overwhelmingly positive.

With this expansion, we now have receptionists on duty daily to answer incoming calls, greet visitors and family members and on weekends to conduct tours of the facility.

We will be holding a holiday open house to invite the community as well as hospital social workers and care managers, eldercare attorneys and referral agencies.

With more and more people using the internet to find Assisted Living facilities our website was redesigned and expanded in August.




