

## **55** Years and Counting

Fifty five years ago on October 30, 1966, Heath Village officially opened its doors to seniors in the region. "When I first had the idea for a housing community dedicated to the elderly, people thought I was crazy, but I was not to be dissuaded. I knew it was the right thing to do. Seniors needed a place like Heath Village to call home," said founder, The late Reverend Clarence W. Sickles in 2017 when asked about the early days when Heath Village was just a dream. "Back then, I couldn't envision what it is today. It has far exceeded what I had in mind."

Thanks to Reverend Sickles' vision and perseverance and the hard work of several other dedicated community leaders, Heath Village stands today as the second oldest senior living community in New Jersey.

"While certainly the pandemic has been difficult, in no way has it undermined the Heath Village story. The resilience demonstrated by both residents and staff during this difficult chapter in our history only stands as further evidence of our community's strength, dedication, and commitment to serving the region's seniors for many years to come," said Patrick Brady, Heath Village Executive Director. "It has been an honor to serve the senior population for 55 years and we look forward to an exciting future that includes building additional independent senior living cottage-style apartments on the property adjacent to the Meadows," said Brady.

Happy Retirement!

After an incredible 34-year career, our CEO and Executive Director Mr. Brady has announced his plans to retire at the end of 2021.

It is hard to believe that during its 55-year history, Heath Village has only had three Executive Directors – our founder The Reverend Clarence W. Sickles, Charles Peters, and finally, arriving in 1988, Patrick E. Brady. Heath Village stands today as one of the finest retirement communities in the state in large part to Mr. Brady's leadership, strategic planning, hard work, and dedication to serving the senior population.

"I can hardly believe it has been a quarter of a century serving on the Heath boards with Pat Brady. During all that time, I never had a worry that he was anything but the perfect person in the ED/CEO position. Every time I went to a Leading Age national conference, I came away proud that our communities were cutting edge and often years ahead of almost all other facilities, even larger and more expensive organizations. I never want to think that anyone is irreplaceable, but Pat comes as close as anyone I have ever worked alongside. I especially commend him for his support and empowerment of women in leadership roles," said Carol McKinney, Chair, Heath Village Board of Trustees.

Brady is particularly proud of the Friendship Center. "A retirement community hosting a childcare center with resident volunteers was a novel idea 30 years



ago. Many of my fellow Heath Village board

members had doubts about it, but Pat saw it as a plus for the residents and for the children, and he has always liked novel ideas," said John Reynolds, Friendship Center Founder and Board member. "A thousand or so kids and who knows how many Heath Village volunteers and Pen Pals later, the success of the Friendship Center has proved him right," said Reynolds.

The Friendship Fund was also a priority for Brady who has worked tirelessly to maintain it. In 1989, soon after his arrival, he organized the inaugural Benefit Dinner. In 1990 he spearheaded the "Gift from the Heart" campaign that raised more than \$500,000 for the Fund. He also created the Friendship Fund Gift Annuity Program which to date has raised nearly \$1.5 million.

"Mr. Brady has been an excellent mentor during my twelve years at Heath Village. I have learned much from him and have always been impressed by his commitment to the community's residents and staff," said Mary Ellen Bove, Heath Village Chief Operating Officer and Administrator. "I am grateful for the opportunity I have been granted to succeed him and look forward to building on his legacy," said Bove.
